A NOTE FROM PHILIP C. SNEED ARVADA CENTER PRESIDENT AND CEO



We are proud to present The Laramie Project, a play that had its genesis in our own backyard - in the tragic event (and its aftermath) that took place just over our northern border, and also in Denver, where the play was partly developed and had its premiere at what was then called the Denver Center Theatre Company. At the time the play opened - February of 2000, just 16 months after the murder of Matthew Shepard - the events were still very fresh in the minds of many. One didn't have to look far to find someone who was from Laramie, or went to college there, or had family or friends who knew one of the "characters" in the story. The play and its production had an enormous impact, locally and nationally; TIME Magazine named it one of the ten best plays in the country that year, and it was adapted into a film by HBO.

We are now 25 years past Shepard's murder, and that specific hate crime may not be as well known today, especially by younger people and those new to the region. This is all the more reason to produce the play, of course – in the same way that it's important to continue to offer such works as *The Diary* of *Anne Frank*. We must never forget the Holocaust, and we must also never forget the brutal killing of Matthew Shepard, and by extension, the violence that happens every day to members of the LGBTQ+ community. Sadly, the number of hate crimes against this vulnerable population – and especially against members of the transgender and non-binary community - are increasing.

It's worth acknowledging that some will always question whether the theatre should tell such stories at all. Every producer and artistic director has heard the alltoo-common refrain, "I just want to be entertained." And don't we all, to some extent? Much of what theatre companies produce could be said to fall into the category of "entertainment" (speaking of which, don't miss our VERY entertaining production of Beautiful: The Carole King *Musical*, plaving in our Main Stage during the first part of the run of The Laramie Project, or the holiday musical, Rodgers and Hammerstein's Cinderella). Yet the theatre has always tackled tough and controversial subjects, all the way back to the dramas and even the comedies of the Golden Age of Greece. Many of Shakespeare's plays addressed current events, and in more recent times, there have been plays like The Crucible - which dramatized a story of the Salem Witch Trials but was actually an allegory about McCarthyism and the "Red Scare" of the 1950s - and Angels in America. which tackled the AIDS crisis of the 1980s. among other topics.

Fortunately, the art of theatre is expansive enough to include many works which "just entertain," as well as works which challenge us to think about the world around us. I hope *The Laramie Project* will be such a play for you – whatever your personal beliefs, the rise in the number of hate crimes in recent years is something that I hope everyone can agree needs to be addressed. The next victim could be a friend, a neighbor, even a family member.

AUTHOR'S NOTE BY MOISÉS KAUFMAN DATED 2001

The Laramie Project was written through a unique collaboration by Tectonic Theater Project. During the year-and-a-half development of the play, members of the company and I traveled to Laramie six times to conduct interviews with the people of the town. We transcribed and edited the interviews, then conducted several workshops in which the members of the company presented material and acted as dramaturgs in the creation of the play.

As the volume of material grew with each additional trip to Laramie, a small writers group from within the company began to work closely with me to further organize and edit the material, conduct additional research in Laramie, and collaborate on the writing of the play. This group was led by Leigh Fondakowski as Head Writer, with Stephen Belber and Greg Pierotti as Associate Writers.

As we got closer to the play's first production in Denver, the actors, including Stephen Belber and Greg Pierotti, turned their focus to performance, while Leigh Fondakowski continued to work with me on drafts of the play, as did Stephen Wangh, who by then had joined us as an Associate Writer and "bench coach."

A NOTE FROM KATE GLEASON DIRECTOR OF THE LARAMIE PROJECT

When I first was introduced to this production in 2000, I was struck by the title, *The Laramie Project*. A Project- not simply a play or a historical drama. It's title suggested something deeper and more complex.

One notable definition of "Project" can be found in the Cambridge Dictionary as "a piece of planned work or an activity that is finished over a period of time and intended to achieve a particular purpose." I began to ask myself what is the purpose of this particular project? And will it ever be "finished"?

Originally, members of Tectonic Theater Project went to Laramie, WY for the purpose of excavating and discovering, through observation and interviews, how a community responded to an event that was both traumatic and reprehensible. They explored the root and cause of such hatred and violence. They also uncovered real examples of compassion and forgiveness. The people who took part in these interviews are real people, not just characters created by a single playwright. They speak for themselves. It is an oral history and one of the most important of its kind. Their words weave together an essential truth about our society, both good and evil.

Every production of this play should be seen as a project. A task of investigation. A pursuit of something difficult and necessary. Every actor, director, designer, crew member, and audience member is part of this project. It urges us to examine the preconceived notions we bring with us into this space. What will we take with us when we leave? What will we learn? In this sense, it is absolutely an ongoing project- one that continues once we leave the confines of the theatre. It is never "finished."

My hope, by engaging in this project and sharing it with our audience, is that we as a community can see that our humanity is tied so deeply to how we listen and treat one another. It is especially vital in this time of unprecedented attacks on our most vulnerable queer and trans communities. Our very survival rests upon our actions.

A NOTE FROM RODNEY LIZCANO DIRECTOR OF THE LARAMIE PROJECT

Matthew Shepard was just two years vounger than me when he tragically died in 1998. I was not out of the closet to my own family and his story not only fueled more fear into my young 23-year-old self, but it also diminished my private hopes that an open queer life would be possible one day. The universal fear of gay and transgender individuals still manifests itself today in mean-spirited and often violent attacks against the LGBTQ+ community. Pick up a newspaper or listen to local or national news - hate crimes toward the queer community and specifically transgender community have reached unprecedented levels and continue to rise.

While the LGBTQ+ community has made considerable progress in the quarter century since Matthew's passing, the lessons we can draw from his life and untimely death resonate just as profoundly today. From Florida's failed "Don't Say Gay" law to the recent violent attack at Club Q in Colorado Springs to state laws banning drag shows to book bans applied against our libraries and public schools, has anything really changed since Matthew's death?

The play *The Laramie Project* ultimately is the story of a small-town community grappling with the healing process after a nationally publicized tragedy. These stories are constantly being re-told with considerable similarities in other contexts – gun violence, racial equality, justice reform, and equity & diversity employment policies. Change, to me, occurs when we, our families, and communities confront hate and bias and can reflect and question our own political and societal leanings, our religious views, and not wait when our homes and those close to us are also faced with tragedy. Laramie, Wyoming was put to the test on a national level that questioned "What is love?" "What is hate?" And how does something like this happen in a small town populated with good and decent people? I hope you will receive this play with an open mind and open heart. I hope that this tragic event in Laramie, Wyoming sparks conversation in your homes. I hope you may see yourself, a loved one, a relative or a neighbor who could benefit from unconditional love and support.

May Matthew Shepard remind us all of what hate can do and what community can accomplish in the name of one of our own.
